# ST JOSEPH COUNTY GOP TOP FIVE ISSUES AUGUST 2023

- 1-a) In April-May of this year, Erich Speckin, a forensic document analyst, performed a recount of paper ballots in Detroit from the 2020 presidential election. He was not allowed to touch the ballots, nor to analyze them very closely, nor was he allowed access to the machines or the digital ballot images. However, based on a simple examination of the paper ballots, he found tens of thousands of discrepancies. Many precincts had more mail in ballots than envelopes, or vice versa. Many precincts reported totals that were different than the number of paper ballots present. Some precincts had reported vote totals to the state, but their machine printout read ZERO votes cast. Of the precincts he examined, many of the mail in ballots had no corresponding mail in ballot applications (which are legally required). Both he and the Detroit staff pointed out differences in paper and ink between some of the ballots, though he was not allowed to touch or analyze the paper or ink directly (which is listed as one of his professional skills).
- 1-b) His 6 PAGE REPORT STRONGLY RECOMMENDS FURTHER INVESTIGATION, particularly including examination of the machine data, which he is willing to do. He does not list the Biden-Trump vote totals found in the recount. This information is not surprising, as it dovetails well with some of the findings from the famous audit of Maricopa county Arizona. It does, however, fly in the face of the claims by Democrats that this was the most secure election in history, as well as similar claims by Republicans such as Ed McBroom. # 1-c) COVER UP OF 10,000 MUSKEGON FRAUDULENT BALLOTS 3 YEARS AGO:

Muskegon City Clerk (**Ann Meisch**) notice a black female (name redacted from 1<sup>st</sup> police report now known as **Brianna Hawkins**) dropping off between 8,000 to 10,000 completed voter registration applications at the city clerk's office on October 8, 2020. Many of these registrations were found to have the same handwriting. Then suspicions were raised further when the same female hand-delivered another 2,500 applications at the last day of turning in voter registrations on October 20, 2020. Ann Meisch has been City Clerk since 2007, and she was city clerk for other Michigan cities for 17 years before that. City Clerk Ann Meisch and Deputy Clerk Kimberly Long contacted Police on October 16, 2020.

# 1-d) Observations of these Voter registrations by the City Clerk and Deputy Clerk include:

- All the voter registrations hand delivered by this "Black Female" appeared to have the same handwriting and also similar handwritten signatures.
- Some of the addresses appeared to be invalid or non-existent
- Some House numbering do not exist in Muskegon's House numbering system
- One of the addresses reported was he Muskegon High School which is not a valid address
- Some of the phone numbers appeared to also be invalid
- Some signatures did not match those on file at the voter registration databases maintain by the state
- Democrat SOS Jocelyn Benson purposely advised clerks to illegally assume and presume the signatures match.
- NOTE: The word "**some**" was mentioned in initial police reports but later one's indicated "**most**" instead.

# 1- e) Observations about Mail-In Ballots include:

- All the ballots appeared to come from the same company with two locations in Southfield and Auburn Hills, Michigan
- Also the handwriting on the ballots appeared to be the same with a similar signature (probably the same as the voter registrations submitted

# 1-f) City Clerk Ann Meisch and Deputy Clerk Kimberly Long contacted Police on October 16, 2020, and again on October 20, 2020.

City Clerk told police about the Black Female (Brianna Hawkins) who told her employment entailed registering voters and helping them obtain absentee ballots. She also provided police a 42 samplings of fraudulent voter registration, and absentee ballot applications. They were identified by viewing Brianna's Facebook profile. Police Detective Logan Anderson and Captain Shawn Bride conducted a non-custodial interview with the suspect on October 20, 2020 the day she delivered another 2,500 registration forms.

In this interview with Brianna, she told police was paid \$1150/week "to find unregistered voters and provide them with a form so they can get registered to vote" or "obtain their absentee ballot". So after the Michigan SOS and Governor were also contacted by the Muskegon Police department in the weeks following October 20, 2020 the FBI was notified. The SOS and FBI promptly buried the police report. The police Report consists of 2 separate reports. PART 1 and PART 2

# Muskegon Police Report (2020-19124) – Key Findings

- **GBI Strategies LLC** is the organization that is running the election fraud scheme based in Tennessee. GBI Strategies started in 2014.
  - GBI Strategies, LLC is a Democrat backed organization, and was paid \$11 million dollars by a Joe Biden Super PAC in 2020 to get elected with operations in 20 different states.
  - Police Report identifies the name "Brilus" as a primary person involved.
  - GBI Strategies was paid \$1,571,386 by the Doug Jones Senate Committee back in 2018
  - GBI Strategies was paid \$188,000 by the Democratic Campaign Committee in 2018.
  - GBI Strategies owner Gary Bell manages over 70 "organizing operations" in 20 states and lends logistical and consulting support to another 7 states.
  - Bell is very strongly connected to far left wing groups such as: DSCC, DNC, Black PAC, IBEW, and SEIU to name a few
- The employees GBI Strategies were paid \$15 per hour, and \$120 per day for the Voter registration work and absentee ballot applications submissions
- A woman interviewed by police indicated that she was paid \$1150 per week and she was given a rental car, and a "reloadable cash card".
- Police reported that hundreds of pre-paid cards from different companies along with dozens of new burner phones were found in a Southfield raid most of them unopened and never used.
- Police also report noted that numerous job openings listed in Flint, MI, & in regional field sources in Washington DC & in Chicago IL, with branches all across the nation for employment for GBI Strategies.
- Police also found pelican cases in the room with semi-automatic rifles joined with suppressors and optics and customized pistols. One case had 4 rifles and 4 pistols. All were determined to be legal after notifying the ATF to inspect the weapons.

So why are we finding all of this out now on August 8, 2023? The answer is very simple – the investigation was handed over to the FBI who happily quashed it, but the real reason is that Republican Attorney General Bill Barr never wanted people know about it so he could claim that there is no solid evidence of election fraud.

Former Trump General Council Personnel Police Operations Andrew Kloster revealed that there even was an arrest at the local level, but because Barr had a standing order issued to IGNORE all election fraud matters, Kloster did not want to violate the AG standing order.

# **3. BIG PHARMA CORUPTION**

- 35,911 COVID Vaccine Reported Deaths / 45,909 Total Deaths
- 208,190 Total COVID Vaccine Reported Hospitalizations / 294,905 Total Reported Hospitalizations

- All Through August 11, 2023

Part of the problem with VAERS is that deaths are only attributed to the vaccines if they occur outside of a two-week window. #### 5. 2nd Amendment
