
# St Joseph County TOP THREE ISSUES June 2024

#### 1) ELECTION INTEGRITY

Note the red line showing statistically unlikely actual ballots recorded in 2020



Population from US Census Bureau Registrations & Ballots cast from January 2021 Qualified Voter File (QVF) from state of Michigan St. Joseph County reported 28,125 ballots cast for November 2020. In January 2021, only 27,254 vote histories remained. The difference is 871 votes.

Note the place this is made possible is inflated voter registrations (dark blue line)

#### 3) SECOND AMENDMENT:

Governor Whitmer announced recommendations for her proposed budget. Those recommendations included \$2.6 million for implementation of the new "Red Flag" law and a further \$1.8 million in grants for community-based organizations that provide training and programming related to implementing this law. The \$2.6 million for implementation of this law seems to be a sound investment; however, specific details are difficult to find. We must remain vigilant to ensure that the money is spent on training that ensures both the safety and constitutional rights of all involved in enforcing the "Red Flag" law.

Specific details about the "community-based organizations" that are going to benefit from the \$1.8 million the Governor wants to allocate are a bit sparse as well. You get a good idea of who they are when reading the Governor's <u>6-20-2024 press release</u> touting the establishment of the Michigan Gun Violence Prevention Task Force. The Task Force itself is detailed in the <u>Governor's Executive Order</u>. The Governor's order notes that "Michigan has one of the highest rates of gun violence in the nation." This is despite Michigan enacting firearms laws since 1914. Time will tell whether this Task Force represents an honest effort to reduce gun violence in Michigan or becomes another ineffective bureaucracy. The Executive Order gives it just 540 days after its first meeting to complete its task.

On 6-14-2024, the U.S. Supreme Court upheld a 1994 ban on firearms possession by people under domestic violence restraining order(s). Michigan already bans those convicted of assault or domestic violence from obtaining a Concealed Pistol License for eight years (MCL 750.81). The "Red Flag" law, if enforced properly, seems to be in line with Friday's ruling. Ron A., Matt A.
